**(4) Objects:**

1. To render voluntary Service for the welfare and development of Common People both in rural and urban areas, irrespective of their cast, creed, religion, language, sex or other discriminating factors.
2. To establish, maintain and manage Schools, colleges, Professional College, Technical and non technical institutions of all kinds with hostel and/or boarding facility including Research institutions for good education and advancement of knowledge to poor and unaffordable people with women's education.
3. To establish and run special schools and Institutions for physically and mentally retarded people in the Community.
4. To establish and run Care Homes/boarding homes for orphan children aged people, widows, destitute and retarded women and children.
5. To run meditation yoga training centers, Computer training centers and study Centers.
6. To Manage all educational Courses and Program of Technological, Management, M.B.A. M.C.A. Trades, Apprentice ship and other Technical Institutions Literature, Art, Social Science, Commerce, Science etc from Primary to higher educational which can be Manageable by the Trust according to law.
7. To manage all the study programs related to public health and welfare permitted by U.G.C and its units which can be manageable by Trust according to law.
8. To manage such type of investigation and research Program which can be manageable by the Trust according to law.
